The Institute

The **Research Institute Foundation of the Hospital de la Santa Creu i Sant Pau** (IR Sant Pau) is a scientific foundation whose mission is to improve the health and quality of life of the population through the production and dissemination of scientific knowledge, the training of researchers at an international level, and the promotion of innovation and health by incorporating medical advances into clinical practice and healthcare policies. Created in 1992, it has been an excellence research center affiliated with the Autonomous University of Barcelona (UAB) since 2009 and has been a CERCA (Catalonia Research Centers) center since 2011.

For the Foundation, it is a priority to ensure that the most suitable candidate is hired to fill a job through an open, transparent, and merit-based selection process (OTM-R). Following these guidelines, staff mobility, knowledge exchange, and, ultimately, the increase in the quality of teaching and research will be enhanced. Faithful to our commitment to the European Union's human resources strategy, our institution's personnel selection and recruitment procedures are governed by a set of basic principles that guarantee equal access to employability for all. About the Platform:

The Sant Pau Research Institute has created the Center for Advanced Therapies to promote research in advanced therapies, increase production capacity under Good Manufacturing Practices (GMP), and enable the transfer of these therapies to the population.

The creation of this center is a strategic step to provide research groups with the necessary resources to carry out advanced therapy projects, offer specialized services, and provide consultancy to both public and private sectors. The center already includes a Clean Room and has several active Advanced Therapy Medicinal Products (ATMP) projects, including academic clinical trials with CAR-T cells. It will also feature new state-of-the-art facilities for the production of these therapies under high manufacturing standards, placing the Institute at the European forefront in this field. The selected candidate will report to the Technical Director of the facility.

Essential requirements

- Higher Education (University Diploma or University Degree) or equivalent.
- Oral and written proficiency in both official languages of Catalonia, or alternatively, the selected candidate must demonstrate or commit to acquiring, within a maximum of one year, proper knowledge of both official languages of Catalonia.
- Reading level of English.
- Proficient user of office tools (Excel, Word, PowerPoint, etc.).

Skills will be valued

- Knowledge of Good Manufacturing Practices (GMP), particularly in Advanced Therapy Medicinal Products (ATMP-GMP).
- Training and experience in working procedures in clean rooms for medicinal product manufacturing.
- Training and experience in Quality Management Systems.
- Analytical skills, teamwork, initiative, organization, and task prioritization abilities.





Functions

- Environmental microbiological control of classified areas. Sample collection and logistical management of samples.
- Collection of primary data on environmental conditions in classified areas.
- Reception of materials. Approval/Reject management in accordance with approved procedures.
- Monitoring of material stocks in storage and classified rooms. Material logistics management.
- Support in managing operations related to maintenance, calibration, qualification, and equipment repair plans.
- Disinfection of manufacturing equipment.
- Order tracking and delivery note management.
- Tasks related to their functions within the GMP Quality Management System.

At the end of this period, without having been notified of an express resolution, the interested parties will be entitled to understand that their applications have been rejected.

Santa Creu i Sant Pau Hospital Research Institute Foundation may declare this call for applications closed if, according to its criteria, the candidates does not meet the conditions that the Institution considers necessary to fill the position.

The interpretation of the requirements and their enforceability to the candidates will be exclusive to the Santa Creu i Sant Pau Hospital Research Institute Foundation.

PERMANENCE COMMITMENT: Selected persons who will hold the summoned or vacant position, will not be able to apply for a new call until 1-year period has expired. In case of part-time job positions, this period will be of 6 months. In both cases, the period will compute from the date of publication of the resolution. The vacant summoned, and the ones that derive from it (intern movements), will be successively covered on the same proceeding among the submitted candidates to each particular call, regardless of whether this entails coverage of places in turns other than the call.
